Ladies and gentlemen,

It is a great pleasure to participate today in this important business forum. I would like to congratulate the President as well as all the people of the Greek African Chamber of Commerce, for organizing it. At the Ministry of Foreign Affairs, we steadily support your initiatives and we are ready to listen to your proposals for future projects.

And now it is the perfect timing, as our country is on a steady growth path, and is rebounding strongly. Just to mention that some days ago The European Commission considerably raised its forecast for Greek growth this year, to 7,1% compared to its previous estimate for 4.3% and the government's latest projection for 6.1%. In addition, the presence in Lusaka of major Greek companies from the sectors of pharmaceuticals, food products, plastics, construction materials, infrastructure development and waste water treatment, is an excellent opportunity to actively explore business opportunities.

In this framework, Greece can also contribute its expertise in the development of the agricultural sector in Zambia. The primary sector in Greece has traditionally proved of pivotal importance for our economy, especially with regards to the welfare of our rural areas. Renewable Energy Sources, sustainable farming and aquaculture are only indicative areas of potential cooperation.

In particular, the energy sector is an area where mutual synergies could develop. I am confident that Greek experience could be a valuable component for developing new projects or for upgrading existent power networks in Zambia.

I would also like to take this opportunity to mention that the business climate in Greece has become very favorable for potential investors.
